Parking Yard #13, previously located at 463-481 Pleasant Valley Way, has been relocated to 4 Haller Road due to construction of the new Chase Bank on that site. The Land Use Board approval for the Chase Bank at 471 Pleasant Valley Way required that left turns out of the rear Municipal Parking Yard be prohibited.

New Parking Yard #16, located at 665 Eagle Rock Avenue, is located on the westbound side behind the Pleasant Valley Way businesses, and is utilized by local residents patronizing those businesses. This lot has been newly constructed, replacing parking spaces lost due to the construction of the Chase Bank.

WHEREAS, Sun Development also submitted separately from its bid the required Certification as to its meeting the qualifications for a New Hotel ABC License and its 12-page Application for such license; and

WHEREAS, Sun Development purports and appears to meet all the qualifications set forth in Resolution #608-18, and in the applicable New Jersey statutes and regulations to be a Licensee for the proposed Licensed premises at the Cambria Suites Hotel at 12 Rooney Circle, West Orange, NJ; and

WHEREAS, those qualifications of Sun Development are subject to the usual ABC investigation by the West Orange Police Department, which investigation has commenced;

NOW, THEREFORE, BE IT AND IT HEREBY IS RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WEST ORANGE, SITTING IN ITS CAPACITY AS THE WEST ORANGE TOWNSHIP ABC BOARD, that the bid in the amount of \$50,000 from the
