

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-37.1b MUNICIPAL PARKING YARDS; METERED PARKING, PERMIT PARKING, TIME LIMITED PARKING, AND SUBSECTION 7-50.3h PARKING METERS IN PARKING YARDS, PROHIBITED PARKING OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-37.1b, Municipal Parking Yards, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Section 2. Subsection 7-50.3h, Prohibited Parking, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

8. For Municipal Parking Yard #11 on Seward Street, parking by commercial vehicles as defined in subsection 7-14.10 is hereby prohibited.

Section 3. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of this Ordinance are severable.

Section 4. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 5. This Ordinance shall take effect upon final passage and publication in accordance with law.

LEGISLATIVE HISTORY

Parking Yard #11, located at 112 Whittlesey Avenue, was sold previously by the Township to a private owner who constructed a two family home on the site. New Parking Yard #11, located at 51 Seward Street is located adjacent to Colgate Park, and is utilized by local residents, recreational users of Colgate Park and Ginny Duenkel Municipal Pool, and overflow parking from Thomas A. Edison Central Six School. This lot has been used for this purpose for many years, but was not previously designated as a Township Parking Yard. This designation will assist West Orange Police with Parking Enforcement, and specifically prohibit the parking of commercial vehicles there.
