

**AN ORDINANCE AMENDING AND SUPPLEMENTING
CHAPTER 7, TRAFFIC, SUBSECTION 7-26, BUS REGULATIONS,
SUBSECTION 7-26.1, BUS STOPS, OF
THE REVISED GENERAL ORDINANCES OF
THE TOWNSHIP OF WEST ORANGE**

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-26.1, Bus Stops, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows (*italic type denotes deletion, bold type denotes addition*):

Street	Hours
Bus Route #29X	
1. <u>Along Pleasant Valley Way, northbound, on the easterly side thereof at:</u>	
a. Woodland Avenue – (Near Side) Beginning at the southerly curblin<u>e</u> of Woodland Avenue and extending 105 feet southerly therefrom.	All
2. <u>Along Pleasant Valley Way, southbound, on the westerly side thereof at:</u>	
a. Fairway Avenue – (Far Side) Beginning at the southerly curblin<u>e</u> of Fairway Avenue and extending 100 feet southerly therefrom.	All
b. Rosemont Terrace – (Far Side) Beginning at the southerly curblin<u>e</u> of Rosemont Terrace and extending 100 feet southerly therefrom.	All
c. Woodland Avenue - (Far Side) Beginning at the prolongation of the southerly curblin<u>e</u> of Woodland Avenue and extending 100 feet southerly therefrom.	All

Section 2. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or applications and to this end, the provisions of this Ordinance are severable.

Section 3. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 4. This Ordinance shall take effect upon final passage and publication in accordance with law and approval by the County of Essex Board of Chosen Freeholders, New Jersey Transit and the New Jersey Department of Transportation if required.
