

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-46.2, PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN DAYS ON CERTAIN STREETS SERVICING RESIDENTIAL LAND USES, EXCEPT BY PERMIT AND SUBSECTION 7-14.3, PARKING TIME LIMITED ON CERTAIN STREETS DURING CERTAIN HOURS OF CERTAIN DAYS OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey, as follows:

Section 1. Subsection 7-46.2, Parking Prohibited During Certain Hours on Certain Days on Certain Streets Servicing Residential Land Uses, Except by Permit, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows (*italic type denotes deletion, bold type denotes addition*):

Section 2. Subsection 7-14.3, Parking Time Limited on Certain Streets During Certain Hours of Certain Days, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Section 3. If any provision of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or applications and to this end, the provisions of this Ordinance are severable.

Section 4. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 5. This Ordinance shall take effect upon final passage and publication in accordance with law.

LEGISLATIVE HISTORY

This Ordinance, designates Glen View Drive between Northfield Avenue and Beacon Place as a Restricted Parking Street on all days between the hours of 5:00 A.M. and 12:00 Midnight, and 12:00 Midnight and 2:00 A.M. During these hours parking will only be allowed by permit with permits issued only to residents of this section of Glen View Drive and their guests. This section of Glen View Drive is used for parking by bus commuters, employees and customers of local businesses, and employees and visitors of local institutions along Northfield Avenue. Between the hours of 5:00 A.M. and 12:00 Midnight and 12:00 Midnight and 2:00 A.M. this Ordinance will curtail parking on this section of Glen View Drive by bus commuters, employees and customers of local businesses, and employees and visitors of local institutions. Parking between the hours of 2:00 A.M. and 5:00 A.M. is already prohibited by the overnight parking prohibition regulation. This parking by permit regulation does not provide an exemption from the overnight parking regulations.
