Transit Orange Train Station: AM Discharge on Route 280 side of platform and PM pickup on Main St. side of platform next to Depot Building. South Orange Train Station: AM

Discharge and Pickup located on South Orange Avenue westbound at railroad overpass.

Mountain Train Sta.: AM Discharge is in parking lot adjacent to inbound platform, PM pickup is

in parking lot adjacent to eastbound platform. For PM service, shuttle bus arrival time at neighboring stops are approximate. L - Shuttle Bus may leave ahead of schedule after train

arrives in station.
